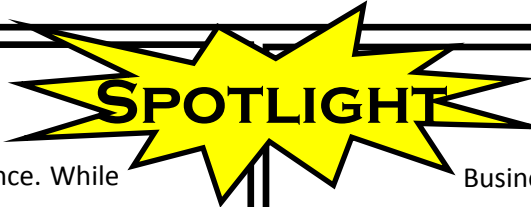
Alpha Kappa Volunteers

Lauren currently resides in Aurora with her husband. They

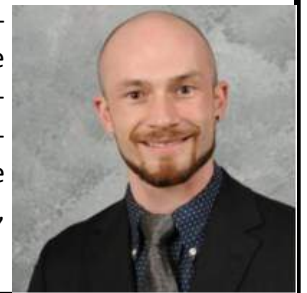


recently received the exciting news of expecting their first child in March 2016. In her free time, Lauren loves to travel, spend time with family and friends, CrossFit and volunteer.

Michael Del Zoppo

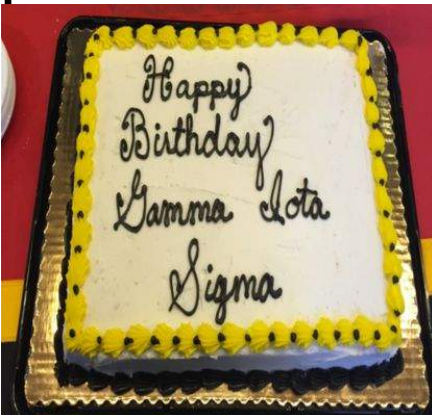

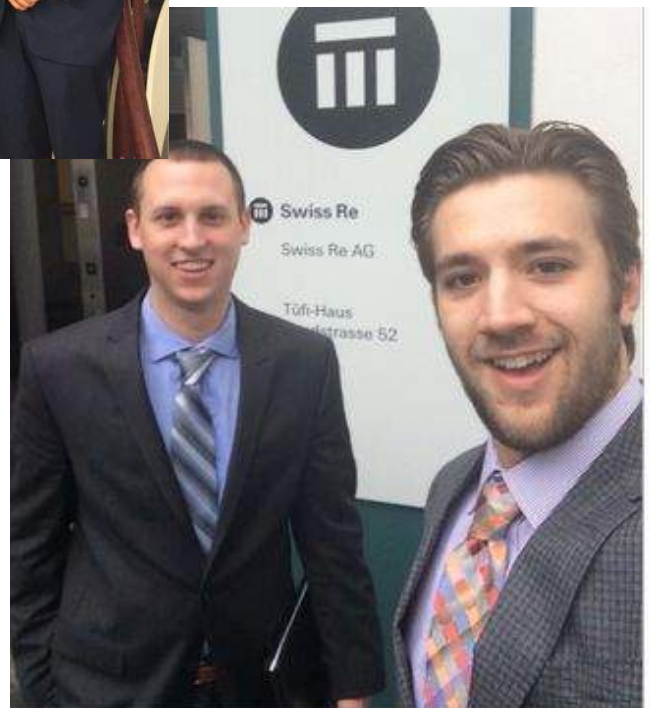

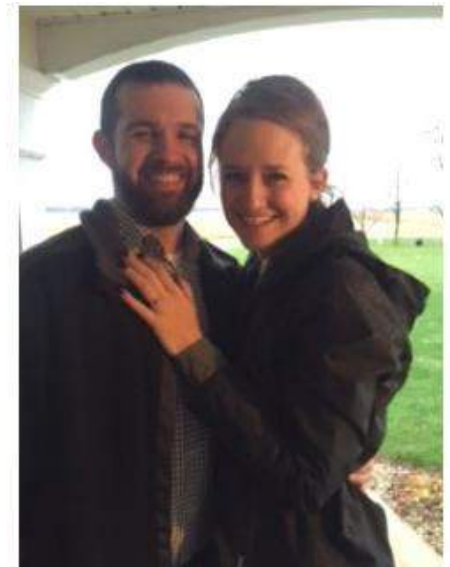
Brett Glaser (13) will be relocating to Chicago from Atlanta in July or August 2016 for General Star as an underwriter in the Property Brokerage Division.

Bert Margis (04) and his wife, Kimberly, are expecting a baby girl in May!

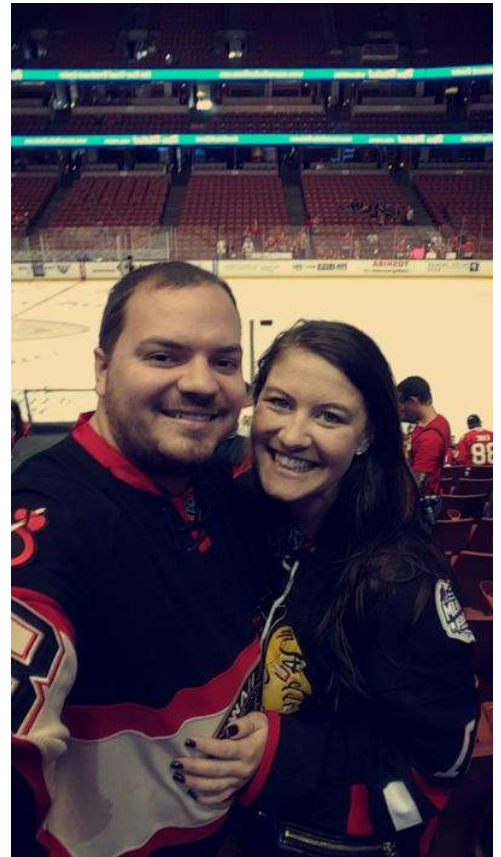

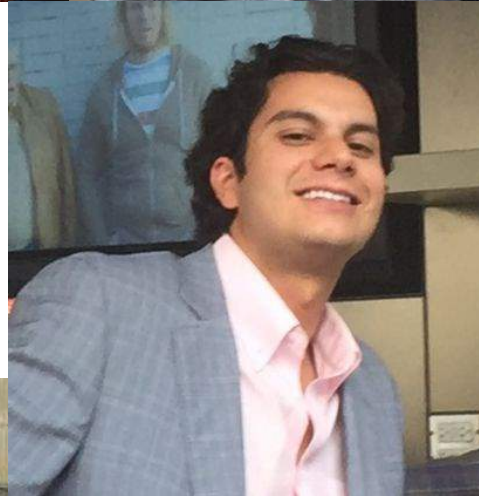

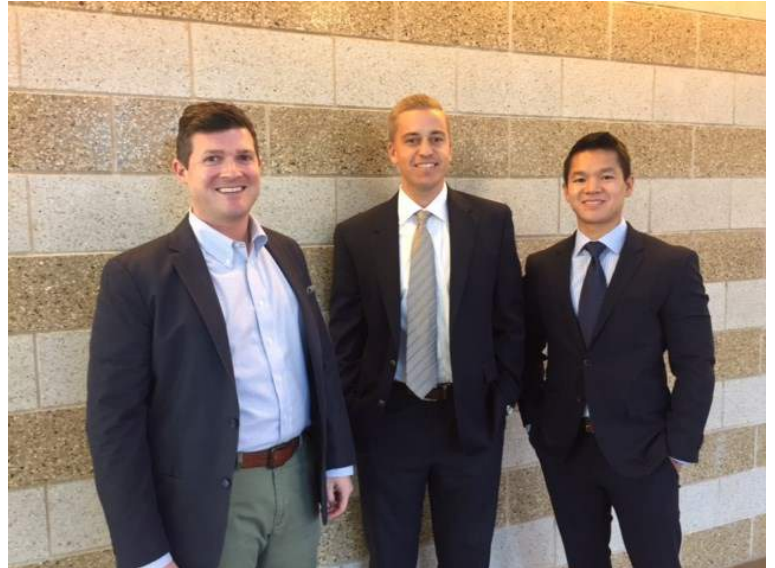
